

Informacja o krajowej i międzynarodowej współpracy kryminologów

POJEDNANIE OFIARY ZE SPRAWCĄ

Organizatorem tej konferencji międzynarodowej była Fundacja im. Heinricha Bolla (Kolonia) oraz Zarząd Główny Stowarzyszenia Penitencjarnego „PATRONAT”, przy współpracy Biura Interwencji Kancelarii Senatu. Odbyła się ona w dniach 26–27 stycznia 1995 r. w Warszawie.

Omawiano na niej m.in. zagadnienia postępowania mediacyjno-restytucyjnych jako sposobu rozwiązywania konfliktu pomiędzy ofiarą i sprawcą przestępstwa, psychologiczne i prawne problemy mediacji, problem pojednania z perspektywy systemu wymiaru sprawiedliwości, możliwości mediacji w świetle prawa polskiego, w szczególności w sprawach o czyny karalne popełnione przez nieletnich. Uczestniczący w konferencji specjaliści z Austrii i Niemiec przedstawili swoją dziesięcioletnią praktykę realizowania programów mediacji oraz działania stowarzyszeń zajmujących się tą problematyką. Przeprowadzono także warsztaty nt. sposobu przeprowadzania mediacji („kto i jak”) oraz społecznych i prawnych przesłanek wprowadzenia mediacji. Odbyła się także projekcja filmu Ewy Cendrowskiej przedstawiającego przykład pojednania i zadośćuczynienia.

TEORIA I PRAKTYKA POJEDNANIA POMIĘDZY NIELETNIM SPRAWCĄ I JEGO OFIARĄ

W dniach 23 i 24 maja 1995 r. w Pile odbyło się szkolenie okręgowe pracowników rodzinnych ośrodków diagnostyczno-konsultacyjnych, na temat teorii i praktyki pojednania pomiędzy nieletnim i osobą przez niego pokrzywdzoną.

Organizatorem był Sąd Apelacyjny w Poznaniu. Przedstawiono m.in. informacje o przetępcości nieletnich i profilaktyce w rejonie pilskim, o znaczeniu problematyki pojednania ofiary ze sprawcą, o prawnych możliwościach mediacji w sprawach nieletnich w Polsce, o zagranicznych doświadczeniach programów mediacji. Zapoz-

nano uczestników z wnioskami dla praktyki wynikającymi z poswięconej tym zagadnieniom międzynarodowej konferencji, która odbyła się w styczniu 1995 r. w Warszawie. Przeprowadzono także zajęcia praktyczne poświecone procesowi mediacji pomiędzy sprawcą i ofiarą.

W jego trakcie przedstawiono między innymi wyniki zagranicznych i polskich badań nad ustaleniami rozmiarów oraz następstw różnych form znęcania się nad dziećmi i ich przestępniego wykorzystywania.

THE POLITICAL SYSTEM BETWEEN CORRUPTION AND PUBLIC FINANCING

International Seminar organized by the International Centre of Sociological, Penal and Penitentiary Research and Studies INTERCENTER (Taormina, 26–29 October, 1995).
