

*THE COMMITTEE OF LEGAL SCIENCES OF THE POLISH ACADEMY
OF SCIENCES*

Three year term of the Committee of Legal Sciences of the Polish Academy of Sciences ended on December 31st 1965. In February 1966, Scientific Secretary of Department I — Social Sciences of the Polish Academy of Sciences called in new members of the Committee for the period of next three years.

The present Committee constitutes of 61 members. The president is again Prof. Stefan Rozmaryn from Warsaw, member of the Polish Academy of Sciences, vice-president — again Prof. Witold Czachórski (from Warsaw). In presidum of the Committee are: Prof.

Manfred Lachs (from Warsaw), corresponding member of the Polish Academy of Sciences, director of the Institute of Legal Sciences of the Polish Academy of Sciences; Prof. Andrzej Burda (from Lublin); Prof. Kazimierz Opałek (from Cracow); Prof. Jerzy Wróblewski (from Łódź). Members of the Committee represent all fields of the Polish Legal Science and university centres in Poland including the Institute of Legal Sciences of the Polish Academy of Sciences. The Committee includes also outstanding lawyers-practitioners.

In January 1966 Presidium of the Polish Academy of Sciences determined directions of work for Scientific Committees of the Academy. Along these lines the Committee of Legal Sciences of the Polish Academy of Sciences basing on authority of its members is to represent the body of legal science in Poland.

The main task of the Committee is to promote scientific discussions, take the initiative tending to enliven scientific activity, and make suggestions as regards the state, trends, and needs of legal science in Poland. The Committee is also to elaborate instructions for long-term plans and five-year plans of research in legal science, co-ordination of works being carried on in Poland and evaluation of their progress. And still, the Committee organizes conferences and panels, makes suggestions as to the publication of scientific papers, considers publishing plans, promotes international co-operation, and gives scientific basis for different specialist organizations.

The Committee of Legal Sciences is also the Polish national committee of the International Association of Legal Science. Polish affiliated sections of four international scientific associations work by the Committee. These are: 1. Polish section of the International Institute of Administrative Sciences; 2. Polish Section of the International Association of Labour Law and Social Security; 3. Polish Section of the International Association of Insurance Law; 4. Polish Section of the International Association of History of Law and Institutions.

First meeting of the new Committee was on February 19th 1966. Prof. Jerzy Starościk read a paper on general principles of the administrative law; a very heated discussion followed the lecture.

Within the works for the VIIth International Congress of Comparative Law the Committee of Legal Sciences prepared Polish papers to be presented at the Congress. All of them have appeared in a book entitled *Rapports polonais présentés au septième Congrès International de Droit Comparé*, edited by Prof. Stefan Rozmaryn. The Committee of Legal Sciences suggested publication of reports presented at the conference on state law which was held in Poland in 1965. The conference materials are to be published as *Zagadnienia współczesnego prawa państwowego* [Problems of Modern State Law]. The collection of papers is to be published in French under the title: *Introduction à l'étude du droit polonais*. These reports prepared by Professors of the Law Faculty, Warsaw University, Stefan Rozmaryn (Chief Editor) are meant for foreign readers dealing with comparative law.
